Heavy Equipment Haulers Take Note! In February, the Town of Stockton and the Portage County UW-Extension hosted a meeting about the impact of heavy vehicles and equipment on roads and related legislation in process, SB 509 and AB 648 allowing an acceptable tolerance of 15% over state weight limits on unposted highways. For IOH's in excess of the 15%, these bills allow for local jurisdictions to give permits to exceed the 23,000 lbs per axle and 92,000 lbs on five or more axles at the local government's discretion. The Stockton Town Board supports these bills as a compromise to give agriculture a tolerable allowance of up to 15% on unposted highways, but retain local control by local jurisdictions to decide upon any additional weights on a case by case basis. We believe this is important to protect our roads, provide safety to the other highway users, and work with our heavy haulers. Look for more information in the July newsletter or call.
